WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

I ACKNOWLEDGE THAT BY SIGNING THIS DOCUMENT, I AM ASSUMING RISKS, AND AGREEING TO INDEMNIFY, NOT TO SUE AND RELEASE FROM LIABILITY BOBRIWKA, INC AND THEIR SHAREHOLDERS, DIRECTORS AND OFFICERS, RESPECTIVE OWNERS, INVESTORS, LANDLORDS, AGENTS, EMPLOYEES, VOLUNTEERS, MEMBERS, CLUBS, SPONSORS, PROMOTERS AND AFFILIATES (COLLECTIVELY "RELEASEES"), AND THAT I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS. THIS PERMIT AND RELEASE IS A CONTRACT WITH LEGAL AND BINDING CONSEQUENCES AND IT APPLIES TO ANY AND ALL ACTIVITIES AT THE CAMPGROUND. I HAVE READ IT CAREFULLY BEFORE SIGNING, AND I UNDERSTAND WHAT IT MEANS AND WHAT I AM AGREEING TO BY SIGNING.

In consideration of the issuance of a camping permit to me by one or more Releasees or the acceptance of my application for camping, I hereby freely agree to and make the following contractual representations and agreements:

I ACKNOWLEDGE THAT CAMPING IN CAMP BOBRIWKA (also known as Bobriwka, Inc) IS AN INHERENTLY DANGEROUS ACTIVITY AND FULLY REALIZE THE DANGERS OF PARTICIPATING, whether as a camper, driver, rider, hiker, or otherwise, and FULLY ASSUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION INCLUDING, by way of example, and not limitation: dangers associated with man made and natural obstacles; the dangers of being attacked or bitten by animals domestic or wild, the dangers of collision with pedestrians, vehicles, other riders, and fixed or moving objects; the dangers arising from surface hazards, including pot holes, equipment failure, inadequate safety equipment, use of equipment provided by Bobriwka, Inc and others, **THE RELEASEES' OWN NEGLIGENCE**, the negligence of others and weather conditions; and the possibility of serious physical and/or mental trauma or injury, or death associated with just being present at the campground or being present in Camp Bobriwka. For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors")

I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISE TO INDEMNIFY AND NOT TO SUE the Releasees and all sponsors, organizers and promoting organizations, property owners, law enforcement agencies, public entities, special districts and properties that are in any manner connected with my stay at the campground,

and their respective agents, officials, and employees through or by which camping is permitted, (the foregoing are also collectively deemed to be Releasees), **FROM ANY AND ALL RIGHTS AND CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASEES' OWN NEGLIGENCE**, which I have or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with my stay, or travel to or return from the campground. I agree it is my sole responsibility to be familiar with the campground's terrain and permitted use, the Releasees' rules, and any special regulations for staying at the campground and agree to comply with all such rules and regulations. I understand and agree that situations may arise during my stay which may be beyond the control of the Releasees, and I must continually observe and otherwise participate so as to neither endanger myself nor others. I accept responsibility for the condition and adequacy of my equipment, and equipment provided for my use, and my conduct in connection with my stay. When riding or driving on any vehicle, I will wear a DOT approved helmet which satisfies the current legal requirements and that can protect against serious head injury, and assume all responsibility and liability for the selection of such a helmet.

It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a **RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the RELEASEES.**

I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert a claim contrary to what I have agreed to in this contract, the claiming party shall be liable for the expenses (including legal fees) incurred by the Releasees in defending the claims. This contract may not be modified orally, and a waiver or modification of any provision shall not be construed as a waiver or modification of any other provision herein or as a consent to any subsequent waiver or modification. I consent to the release by any third party to Releasees and their insurance carriers of my name and medical information that may relate solely to any injury or death I may suffer arising from my stay. Every term and provision of this contract is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.

IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.

I ALSO AGREE to use Camp Bobriwka for the sole purpose of Camping. I understand that all of my guests and any of their actions will be my responsibility. I agree to follow the Bobriwka Rules and Regulations

BOBRIWKA CAMPING RULES AND REGULATIONS.

- ❖ Campers and Guest over the age of 18 are required to sign the **WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT**
- ❖ Parents must accompany and are responsible for their children (under 18.)
- ❖ Camping Fees may be changed at the discretion of the Bobriwka management
- ❖ RV or camper are charged an additional fee
- ❖ 1 campsite = 1 tent/camper/car/van
- ❖ Campsites are limited to 4 family members
- ❖ No firearms of any kind
- ❖ Buildings are off-limits (except bathrooms)
- ❖ Carry out any trash you generate
- ❖ Quiet hours must be observed and will be from 9PM until 9AM.
- ❖ All pets must be leashed. Please clean up after your pet.
- ❖ Fires are to be built in designated areas only or in approved grilles for barbecuing
- ❖ Campers are not allowed to bring or use motorized recreational vehicles on the property
- ❖ Rules and regulations subject to change without notice
- ❖ All Federal, state and local laws will be observed
- ❖ Bobriwka Management can remove any camper and their guests for any reason and without reimbursement
